RELEASE, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

I (Print Name) _____ have voluntarily decided to participate with the Peninsula Long Rifles, a Washington State non-profit corporation, also known as Peninsula Long Rifles Muzzleloading Club, hereafter referred to as PLR. To participate, I will be in or near areas where primitive lead ball and black powder, a commonly used explosive, firearms are owned, possessed and used. These and other primitive arms (throwing knives, tomahawks, and bows and arrows) are used on ranges and wet shooting trails are primitive, steep and can be slippery. I acknowledge and understand there is always the risk of death, serious bodily injury to myself and others, as well as property damage, associated with ownership, possession, and or use of firearms and other arms, whether used by me or others, including simply as a spectator. I accept the risks and responsibilities associated with my participation.

I understand this participation is permitted on a voluntary basis, and no warranties are expressed or implied to me. I acknowledge I may use equipment provided by PLR and or its members, and I may provide my own equipment and supplies. I am responsible for the suitability and security of my own supplies, equipment, and vehicle(s) on PLR property.

In return for allowing my participation in PLR activities whether or not the information, equipment, and or supplies are suitable, appropriate, or correct, I, my heirs, successors, assigns, subrogees, creditors and anyone who may claim by or through me, hereby waive any and all claims for injury and damages, foreseeable or not foreseeable, against the PLR and its members and officers resulting from any and all fault, including negligence and any claims for injury and damages resulting from faulty information, equipment and or supplies. I also indemnify and defend PLR against any claims made others on my behalf and claims made by other people alleging I am responsible for injuring others during my participation with PLR.

I acknowledge that my safety and the safety of others depend on strict compliance with all safety rules. I agree to immediately leave any area when directed to do so, by any PLR officer or range or other safety official. My failure to leave PLR property when directed may result in trespassing charges, and any PLR officer or other range safety official, or PLR member acting in that capacity per the PLR

Bylaws and Range rules may summon and request that a law enforcement agent remove me from the property. My failure to follow PLR rules, procedure, or direction may result in suspension or loss of my membership or use of PLR property.

I acknowledge that I have been asked to carefully review this agreement and have been provided access to the PLR Muzzleloading handbook including the Bylaws, Rules, and Range Safety Rules. I have been encouraged to seek legal advice if I have concern before entering this agreement.

I agree to obey US Federal and Washington State firearms laws and acknowledge that I am not disabled under those laws from possession of firearms and ammunition.

I agree that the foregoing release and assumption of risk, and indemnity agreement is governed by the laws of the State of Washington and is intended to be as broad and inclusive as is permitted by Washington law, and that in the event any portion of this Agreement is determined to be invalid or unenforceable for any reason, the balance of the Agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.

I acknowledge that this document is a contract and agree that if a lawsuit is filed against PLR for any injury or damage in breach of this contract, I will pay all attorney's fees and costs incurred by the PLR in defending such an action.

If the person who is to enter into this Agreement is under eighteen (18) years of age, his/her parent or guardian must read this Agreement and sign below on behalf of the minor.

I HAVE READ THIS DOCUMENT. I UNDERSTAND IT IS A PROMISE NOT TO SUE AND TO RELEASE PLR, ITS OWNERS, EMPLOYEES AND AGENTS, FOR ALL CLAIMS. I HAVE MADE A FREE AND DELIBERATE CHOICE TO SIGN THIS RELEASE AND WAIVER AS A CONDITION TO PLR ALLOWING ME OR MY CHILD TO PARTICIPATE IN ITS ACTIVITIES. I HAVE CONCLUDED THAT THE RISKS INVOLVED AND THE RELEASE AND WAIVER OF LIABILITY IS WORTH THE PLEASURE OF PARTICIPATION.

I UNDERSTAND AND ACCEPT THE TERMS AND CONDITIONS OF THIS AGREEMENT.
